

WHO IS HE REALLY?

GUILTY AS CHARGED

DAVID IRVING

Shunned by the mainstream

publishing and historical communities, he has thrown his lot with the extremists and malcontents of the world — those who wish that Hitler had "finished the job."

Although Irving promotes himself as a defender of free speech, he has frequently filed or threatened to **file lawsuits** against those who criticize his work.

In fact, he seems to believe the First Amendment is an inconvenience, as when he said "I'm going after (Deborah) Lipstadt because she's peddling her book in England; in the U.S. she is protected by ... the First Amendment."

And anyone who disagrees with Irving's views is apt to find themselves listed on his web site as one of the "**Traditional Enemies of Free Speech.**"

This brochure was created and printed by volunteers who believe in free speech, and in the rights of individuals to live in a world free of racism and hatred.

"The [German] judge who sentenced Irving to 3 years described him as a **"falsifier of history dressed up as a martyr" who had denied the "greatest crime of the 20th century"**.

In 2000, Irving sued the US Holocaust scholar Deborah Lipstadt for libel at the British high court and lost. The presiding judge in that case, Charles Gray, wrote that Irving was **"an active Holocaust denier ... anti-Semitic and racist"**. The British judge charged Irving with misleading and partial account, distort the evidence, pervert the evidence, misconceived, fails lamentably, misleading and unsupported, tendentious and unjustified, culpable omission, a distinct air of unreality.

He was fined several thousand pounds in 1992 in Germany for **saying the Auschwitz gas chambers were a hoax.**

The British court found that **Irving's misrepresentation** of history was "deliberate in the sense that he was motivated by a desire borne of his own ideological beliefs to **present Hitler in a favourable light.**"

IRVING THE RACIST

He sang to his little daughter:

**"I am a Baby Aryan
not Jewish or Sectarian.
I have no plans to marry
an Ape or Rastafarian."**

He wrote on his website:

"Americans visiting London often tell me how startled they are at seeing mixed-race couples that stroll around here; I respond that **the females usually appear to be White girls from the lower end of the Bell Curve.**"

Irving told an Australian radio interviewer in November, 1996, "**I don't give speeches to Neo-Nazis.**" One month later, however, **he was the featured speaker at a meeting of the National Alliance**, the "**largest neo-Nazi group in America.**"

ARRESTED, DEPORTED, JAILED.

He has been **banned** from Australia, Canada, Germany, Italy, Israel and New Zealand.

Irving was **arrested in 1989** by the Austrian police in Vienna **on suspicion of neo-Nazi activity** and deported.

In 1992 ... he was **issued a departure notice** to leave Canada on or before midnight, November 1, 1992.

In 1994, the **Australian government banned David Irving** from visiting Australia for a second time Tuesday, saying he was not of good enough character to be given an entry visa.

Banned from entering, Irving tried to sneak into Austria in 2006 to address a right-wing fraternity. He was **jailed for 3 years.**

IN HIS OWN WORDS

"I stand by what I said, **there were no gas chambers in Auschwitz.**"

"Hitler was the best friend the Jews had in the **Third Reich.**"

"I say quite tastelessly, in fact, that **more women died in the back seat of Edward Kennedy's car at Chappaquiddick than ever died in the gas chamber in Auschwitz.**"

"I am not, and was not interested in money, unlike **your fellow religionists [Jews] whose greed is legendary ...**"

"I'm forming an association especially dedicated to all these liars, the ones who try to kid people that they were in these concentration camps. It's called **"The Auschwitz Survivors, Survivors of the Holocaust, and Other Liars" — A. S. S. H. O. L. E. S.**"

On Hadassah Lieberman:
"The 'daughter of a Holocaust survivor'? **Duh.** That is, the **daughter of a woman to whom nothing was done.**"

"Historians have a **blindness** when it comes to **the Holocaust** because like Tay-Sachs disease it is a Jewish disease which causes blindness."

"Women exist for a certain task, which is producing us [men], and **should be subservient to men.**"
